The Board of the Institute of Rock Structure and Mechanics of the CAS announces an open competition for the position of the Director of the Institute.

Requirements:

- University degree and scientific or scientific-pedagogical qualification in the field of geosciences or materials engineering related to research activities of the IRSM,
- Significant results of creative scientific activity,
- Experience with organization and management of scientific research, at least five years of experience in a managing position in science,
- Language skills,
- Fulfilment of legal conditions based on $\S 17$, sect. 4) 6) of Act No. 341/2005 Coll., on the Public Research Institutions, as amended,
- Fulfilment of legal conditions based of Act. No. 451/1991 Coll., which lays down additional requirements for the performance of certain positions (Lustration Act), according to later regulations,
- Moral integrity.

Expected term of office: June 1st, 2022 – May 31th, 2027.

- Evidence of university education and achieved scientific qualification,
- Summary of previous experience,
- List of main scientific achievements and publications,

- Declaration on honour on moral integrity according to § 17 sect. 4 lett. c) of Act No. 341/2005 Coll.
